Dear Auditor of State Payroll Recipient,

March 8, 2024, is fast approaching. Remember this paycheck will be affected by switching from current time to payment in arrears, you will receive half your normal salary.

To lessen the financial impact of a shortened pay cycle, my office worked with Office of Personnel Management (OPM), Employee Benefits Division (EBD), and Arkansas State Employees Benefit Advisors (ARSEBA) on a plan to not withhold certain benefit premiums from that paycheck.

Below is the list of deductions that **will** be withheld from the March 8th paycheck:
